2025 AMSA National Convention Competition ("Competition")

Terms & Conditions

BACKGROUND

- 1. The promoter of the Competition is BOQ Specialist, a division of Bank of Queensland Limited ABN 32 009 656 740 of Level 15, 255 George Street, Sydney NSW 2000 (**Promoter**).
- 2. Information on how to enter and the prizes form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
- 3. By entering the Competition, participants are deemed to accept these Terms and Conditions.

COMPETITION PERIOD

4. The Competition commences at 09:00am AEST on Monday 02 July 2025 and closes at 11:59pm AEST on Monday 07 July 2025 (**Competition Period**). Entries received by the Promoter after the Competition Period are ineligible for the prize draw.

ELIGIBILITY AND PARTICIPATION

- 5. Entry is open only to registered delegates attending the 2025 AMSA National Convention, who are currently studying medicine at any recognised Australian university, and are over 18 years of age (Eligible Participant). Proof of registration may be requested for proof of entry qualification. The Promoter will receive confirmation of attendance of participants from the AMSA National Convention Committee.
- 6. Directors, employees and agents (including the immediate family members of a Director, employee or agent) of the Promoter are ineligible to enter the Competition.
