BOQ "Visa Wellington on a Plate" PROMOTION

TERMS AND CONDITIONS

- 1. The Promoter of the promotion is Bank of Queensland Limited ABN 32 009 656 740 (BOQ) AFSL and Australian Credit Licence No 244616 of Level 3,100 Skyring Terrace, Newstead, Queensland 4006 (**Promoter**). The Promoter's website is www.boq.com.au.
- 2. Information on how to enter and the prize(s) form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
- 3. By entering the promotion, participants are deemed to accept these Terms and Conditions.

Promotion Period

4. The promotion commences on 2 June 2025 and closes at 11:59pm AEST on 25 July 2025 ("Promotional Period"). Entries received by the Promoter after the Promotional Period will be deemed invalid.

Eligibility and Participation

- 5. Entry is only open to Australian residents aged 18 years or over who (a) hold a BOQ Specialist One Account with a linked Visa Debit Card that has been activated; (b) have not opted out of receiving marketing communications from the Promoter; and (c) can travel to New Zealand between 22/08/25 and 24/08/25 to attend the Visa Wellington on a Plate experience. ("Eligible Entrant").
- 6. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. - 10. For the avoidance of doubt, for any entrant who has a joint BOQ Specialist One Account with a linked Visa Debit Card, only one (1) prize will be awarded to holders of the joint BOQ Specialist One Account. - or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
