

## **BOQ Specialist “Visa Wellington On a Plate” Promotion FAQs**

### **1. What is the promotion?**

The promotion is called the BOQ Specialist “Visa Wellington On a Plate ” promotion, where we are giving BOQ Specialist One Account personal customers the chance to win an exclusive trip to New Zealand to attend the Visa Wellington On a Plate event , simply by making a settled transaction of \$60 or more on your personal One Account using your linked Visa Debit Card during the promotional period.

### **2. How long will this promotion run for?**

The promotion runs from 12.00 am AEST 2 June 2025 to 11:59pm AEST on 25 July 2025 (Promotional Period).

### **3. What is the prize?**

The prize is an exclusive Visa Wellington On a Plate travel package for two adults, valued at up to AUD\$8,000. It includes return economy airfares to Wellington, two nights’ accommodation, airport transfers, tickets for two to two Visa Wellington On a Plate Festival Events, Visa Wellington On a Plate goodie bag, and one NZ\$100 voucher to a participating Burger Wellington eatery.

### **4. Who is eligible to enter?**

Australian residents aged 18 years or over who hold a BOQ Specialist One Account in their personal name (either an individual or Joint Account) with a linked and activated Visa Debit Card, have not opted out of receiving marketing communications from BOQ Specialist, and can travel to Wellington, between 22-24 August 2025.

Unfortunately, Employees and their immediate families of BOQ, and agencies associated with this promotion are ineligible to enter.

### **5. What are customers required to do?**

Customers must make a settled transaction of AUD\$60 or more using their Visa Debit Card linked to their BOQ Specialist One Account during the promotional period to receive an automatic entry.

### **6. How do I enter the competition?**

If you already have a BOQ Specialist One Account and your Visa Debit Card is activated, you’re ready go. If not, you will need to open a new One Account under your personal name (either an individual or Joint Account).

To enter, simply make an eligible settled transaction of AUD\$60 or more to earn one entry into the competition.

### **7. Is there a fee to enter the draw?**

No, there is no fee to enter the draw.

### **8. Are multiple entries permitted?**

Yes, every settled transaction of AUD\$60 or more will earn you one entry into the competition, there is no maximum number of entries. The more transactions of AUD\$60 or more you make, the more entries you get!

**9. Do I have to open a new One Account to enter?**

If you already have an existing One Account and your Visa Debit Card is activated, you do not need to open a new account. You can start transacting and for every settled transaction of AUD\$60 or more, you will go into the draw to win.

**10. What does it mean by a 'personal One Account'?**

A personal One Account is either an Individual or Joint One Account that has been opened under your personal details and not those of your business.

**11. What does it mean by a settled transaction?**

If a transaction is showing as 'pending' in your account, it is not yet settled.

A pending transaction means that a transaction has been authorised by the account holder, but it has not yet been processed by the merchant or service provider to the account.

This can occur when a merchant or service provider has obtained authorisation to charge the account but has not yet completed the transaction. This is usually why you'll see a pending transaction right after you've paid for a good or service.

**12. What is considered an 'eligible purchase'?**

An eligible purchase is a settled transaction of AUD\$60 or more made with a Visa Debit Card linked to personal One Account.

The following transactions will not be considered a Qualifying Transaction: Pay Someone transactions, Direct Debits, BPAY payments, Cash outs from a merchant's point of sales terminal, Cash withdrawals from an ATM and purchases in the following Merchant Categories:

- 7273 Dating Services;
- 7995 Gambling and Betting, including Lottery Tickets, Casinos, etc;
- 4829 Money Transfers (including cryptocurrency);
- 6051 Non-Financial Institutions (including cryptocurrency);
- 5813 Drinking Establishments (Alcoholic Beverages); and
- 5921 Package Stores – Beer, Wine, and Liquor.

**13. How will the winner be chosen?**

The winner will be chosen through a random draw conducted at Anisimoff Legal, Level 3/162 Collins Street, Melbourne VIC.

**14. When and where will the draw take place?**

The draw will take place on 28 July 2025 at 1:00pm AEST at Anisimoff Legal, Level 3/162 Collins Street, Melbourne VIC.

**15. How and when will winners be contacted?**

The winner will be notified by telephone and email within two business days of the draw.
