IMPORTANT TERMS & CONDITIONS

BOQ Specialist - a division of Bank of Queensland Limited ABN 32 009 656 740, AFSL and Australian credit licence No. 244616 (**BOQ Specialist**) is the credit provider and and a member of Visa.

This Acknowledgement and Consent applies to you as the primary cardholder and – where noted – the nominated third party.

1. Online banking

By selecting this option, you hereby give the third party authority to register for online banking in relation to *your card account*. You acknowledge that this authority will enable the nominated third party to view your transaction history and statements relating to *your card account*. The nominated third party will be subject to BOQ Specialist's online banking terms and conditions as amended from time to time.

2. Enquiry authority

By selecting this option, you hereby give the third party the authority to request information relating to *your card account* and acknowledge that BOQ Specialist will act on a request made by the third party to disclose such information.

You acknowledge that a third party will have access to and be provided information relating to *your card account* and its operation, including your account balance, the amount of credit available, the minimum payment due, transactions history and statements.

3. Authority to maintain account

4. Power of attorney

5. Privacy acknowledgment - nominated third party

By signing this Form, you acknowledge that you, as the nominated third party, are or will be providing personal information to BOQ Specialist about yourself. BOQ Specialist may also collect personal information about you in the course of your dealings with BOQ Specialist.

As well as collecting personal information from you directly, BOQ Specialist may collect personal information from the primary cardholder, public sources, information brokers and third parties such as those described in this Acknowledgment and Consent (e.g. under 'Authority to disclose information'). You acknowledge that this personal information and any other personal information BOQ Specialist collects about you (**Personal Information**) (whether directly from me or through a third party) may be collected, used and disclosed by BOQ Specialist:

- (a) to verify your identity and complete anti-money laundering and counter terrorism checks as required by law;
- (b) for the ongoing administration of the Facility and your access to it (including security, risk management and complying with BOQ Specialist's obligations at law):
- (c) to enable it to undertake planning, product development, data mining or research;
- (d) in connection with any potential or actual acquisition of an interest in BOQ Specialist; and
- (e) for the investigation and prevention of crime, fraud and illegal conduct.

You acknowledge that not providing the Personal Information may result in this application being rejected.

You understand that BOQ Specialist may store personal information it collects about you in its information systems and physical records.

Subject to the provisions of the Privacy Act 1988 (Cth), you acknowledge that you may access and correct your Personal Information collected and held by BOQ Specialist by making a request to BOQ Specialist. BOQ Specialist suggests that you provide as much detail as you can about the particular information you seek, in order to help BOQ Specialist locate it. BOQ Specialist will provide reasons if it denies any request for access to or correction of personal information. 6. Authority to disclose information - nominated third party
