## FEES

### Annual percentage rate

The *annual percentage rate* which will apply to the unpaid daily balance on your card account is 13.99% for Platinum Credit Card and 20.50% for Signature Credit Card, subject to any interest free period and any Special Promotions, if applicable.

### Interest free period

There is an interest free period on *your card account* of up to 55 days on *purchases* and other debits other than *cash advances* and *balance transfers*.

### Minimum payment due

You must pay the minimum payment due shown on each *monthly credit card statement* on or before the due date, giving due consideration to processing times for each payment method. However, if that day is not a *business day*, it is due on the next *business day*. The minimum amount owing is calculated as the greater of \$20 or 2% of the closing balance (rounded to the nearest 2 decimal points). If the *closing balance* is less than \$20, then the minimum payment due is equal to the *closing balance*. In addition, you must pay any amount in excess of the *credit limit* and any amount shown on the *monthly credit card statement* as overdue. These amounts are due and payable immediately.
