

BOQ Specialist Ultimate Formula 1® Experience Competition

Terms and Conditions:

1. This competition (“Competition”) is promoted by BOQ Specialist - a division of Bank of Queensland Limited ABN 32 009 656 740 AFSL and Australian Credit Licence number 244616 (“BOQ Specialist”).
2. The Competition commences at 9:00am ADST on 1 November 2018 and closes 5:00pm ADST on 31 December 2018.
3. Entry is open only to clients of BOQ Specialist who are aged 18 years or over. Employees (and the immediate family members) of BOQ Specialist and their subsidiaries and related entities are not eligible to enter.
